1. Public Hearing- Consider Board Resolution to Pursue District of Innovation for May ISD

District of Innovation as part of May ISD (MISD)'s consideration of becoming a District of Innovation, the district will hold a public hearing during its regularly scheduled Board Meeting set for Monday, February 20th, 2017 in the May ISD School Library. HB 1842 was passed during the 84th Texas Legislative Session in Spring 2015, and provides Texas public school districts the opportunity to be designated as Districts of Innovation. Districts of Innovation may be exempted from a number of state statutes and will have: Greater local control as the decision makers over the educational and instructional model for students; Increased freedom and flexibility, with accountability, relative to state mandates that govern educational programming; and Empowerment to innovate and think differently. In order to adopt an innovation plan, a district must pass a resolution of the board of trustees, which it will consider on 2/20/2017 at 6:00 p.m. In addition, a public hearing must be held to consider whether the district should develop an innovation plan, at which point the board may decline to pursue the designation of District of Innovation or appoint a committee to develop a plan.
